## **Completing Nomination Form**

This nomination form is required to submit your project for consideration. While all fields should be completed, if a field does not apply to your project, please indicate so. Please be as concise as possible in your submission. You may submit more than one project and each submission should have its own nomination form with attachments. Your photographs and graphics may be submitted in JPG or PDF file format as long as the images are of sufficient quality to be used online. We suggest at least 150 DPI. Your submission should not exceed nine (9) pages. You may submit more than six images as long as the total submission is not more than (9) pages—this means you could include multiple images with a single PDF file.

#### **Awards**

Project of the Year Awards will be given in three divisions:

- 1. Large Counties, population greater than 500,000
- 2. Medium Counties, population between 130,000 and 500,000
- 3. Small Counties, population less than 130,000

The Grand Award will be awarded to one of the three Project of the Year winners.

<u>Peoples' Choice Award</u> will be awarded based upon a vote by County General Services Association Academy attendees.

### **Evaluation Criteria**

- A. *Project Benefits* community and/or employee enhancements, benefits to County organization, benefits to strengthen community, improve service delivery, and improve work environment.
- B. *Community/Employee Enhancement* benefits to strengthen community, improve service delivery, improve work environment.
- C. Cost Saving Measures reduced project cost/value engineering, reduce operations/maintenance costs, avoided costs through improved service delivery.
- D. Aesthetics appropriateness of facility in surrounding context, strength of visual appeal.
- E. Sustainability demonstrated environmental responsibility during design, construction, operations and maintenance of project.
- F. *Innovation* a new practical approach or project type for submitting county that resulted in a successful project.
- G. Creative Funding Approach financing plan that leverages local dollars/minimizes direct County cost.
- H. *Partnerships (public and private)* using projects as a vehicle to build/strengthen relationships, demonstrated collaboration with and buy-in from non-County stakeholder.
